1. Nomination (signed hard copy) for these posts are received from 1<sup>st</sup> July 2018 & must reach the Office of the Hon. Secretary before 5.00 p.m. on 31<sup>st</sup> July 2018, by Registered Post / Speed Post / By hand with ACK due. A copy should be submitted online / by E Mail also to [isanhq@gmail.com](mailto:isanhq@gmail.com) & [secretaryisanhq@gmail.com](mailto:secretaryisanhq@gmail.com). The list of all Nominations received will be published in ISA Office & ISA website on 1<sup>st</sup> August 2018. Incomplete Nominations will be rejected. The list of all valid Nominations will be published by 10<sup>th</sup> September 2018. The Proposer and Seconder must be active Life Members of ISA with eligibility to vote online in their respective Zone.

2. Last date for withdrawal of the Nomination is 30<sup>th</sup> September 2018 before 05:00 PM & the Final List of Eligible Candidates will be published in ISA Office & ISA website on 5<sup>th</sup> October 2018.

3. Last date for Registering for Online Voting is 1<sup>st</sup> October 2018 up to 05:00 PM.

4. The Final voter lists (Online only) will be published in the ISA Website ([www.isaweb.in](http://www.isaweb.in)) on 15<sup>th</sup> October 2018 by 05:00PM.

5. Online voting will be open for 5 days, from 01.11.2018 (08:00 AM) to 05.11.2018(05:00 PM). No Online Voting between 11 PM to 5 AM on any days. Real time count of voting & names of persons who have voted will be available in ISA website. The final details of votes polled will be published immediately after voting is closed on 5<sup>th</sup> Nov. 2018.

6. Elections will be held Online only. No manual voting

7. Eligibility criteria:

a) Contestant must be a continuous member of society for not less than 10 years for the posts of Vice President & President Elect.

b) Contestants for the Posts of Vice President , President Elect , Hon. Secretary & Treasurer should have served one term of office in the Governing Council earlier.

c) For the post of Governing Council Member must be continuous member of society for not less than 5 years.

d) Contestant for Secretary & Treasurer should have been continuous member for 5 years.

e) Contestants should have attended 3 of the Last 5 General Body Meetings & must have signed in the AGBM Register.

f) Each Nomination must be accompanied by a Nomination fee of Rs. 10,000/- (Non refundable) in the form of proof for NEFT / cash deposit in favour of "**Indian Society of Anaesthesiologists**" (**ISA National**) payable at SBI, Kasaragod, Kerala. (Current a/c -SBI Collect- No.35292412841, ISFCODE SBIN0006715)

8. All Life Members of ISA as on 28.11.2017 (Approved by AGBM ) who have registered their E Mail ID & Mobile No. with ISA NHQ only are eligible to Vote. New Members enrolled after 01.12.2017 & old members who do not register their E Mail ID & Mobile No. with ISA NHQ will have all the privileges of his class of Membership, except the right to Vote in this Election.
